SOCIETIES REGISTRATION ACT, XXI OF 1860
(some important provisions)

Sec. 4:-

Once in every, on or before the fourteenth day succeeding the day on which, according to the rules of the society, the annual general meeting of the Society is held, or, if the rules do not provide for an annual general meeting, in the month of January, a list shall be filed with the Registrar of societies, of the names, addresses and occupations of the Governors, Council, Directors, Committee, or other governing body then entrusted with the management of the affairs of the society.

Sec. 4(A) (1):-

Together with the list mentioned in Sec.4, there shall be sent to the Registrar of Societies a statement showing changes during the year to which the list relates in the personnel of governors, council, directors, committee or other governing body to whom the management of the affairs of the society is entrusted and also a copy of the rules of the society corrected upon date and certified to be a correct copy but not less than three of the members of governing body.

Sec.4 (A) (2):-

A copy of every alteration made in the rules of the society, certified to be a correct copy by less than three members of the governing body, shall be sent to the Registrar of Societies within fifteen days of making such alteration

Sec. 4(B)(1) >

Within thirty days after the holding of every annual general meeting, there shall be filed with the Registrar of Societies a copy each of the balance-sheet and auditors report certified by the auditor under such section (2) of Sec. 5.A.

Sec.4(B)(2) :-

If the President, Secretary or any other person authorized in this behalf by a resolution of the governing body of the society fails to comply with the provisions of sub-section (1) he shall be punishable with fine which may extend to five hundred rupees.

Sec. 5(A) (1):-

Every society shall keep at its registered office proper books of account in which shall be entered accurately - (a) All sums of money received and the source thereof and all sums of money expended by the society and the object or purpose for which such sums are expended;
(b)The assets and liabilities of the society.

Sec.5(A) (2):-

Every society shall have its account audited once every year by a duly qualified auditor and have a balance sheet prepared by him. The auditor shall also submit a report showing the exact state of the financial affairs of the society. Three copies of the balance sheet and auditor's report shall be certified by the auditor.

Explanation:-

A duly qualified auditor means chartered accountant within the meaning of the Chartered Accountants, Act, 1949 or a person approved by the Registrar of societies in this behalf.

Sec.5(A)(3) :-

If the President, Secretary or any other person authorized in this behalf by a resolution of the governing body of the society fails to comply with the provisions of sub-section(1) or sub-section (2) he shall be punishable with fine which may extend to twenty rupees for every day after the detection of the default during which the default continues.




RULES AND REGULATIONS OF THE ORGANIZATION

- w) To undertake any other lawful activities that are conducive to the above objectives and are in the interests of the College and/or its Alumnae.


DEVELOPMENTAL:

- iii) To participate implementation of all health related activity as organized by Govt. Authority from time to time.
- iv) To make awareness about sanitation, cleanliness, birth control, safe drinking water etc.
- v) To organize health camp etc. to provide health services to community in the rural remote areas.
- vi) Provide the differently disabled children treatment & rehabilitation through physiotherapy treatment and Day-care service.

ENVIRONMENT :

- i) To promote environmental and ecological education and research in different fields.
- ii) To educate people of different aspects of bio diversity, environment, wild lives, forest etc. and its benefits by holding meeting and organizing popular talks and science exhibitions etc.
- iii) To organize awareness campaign climate change, global warming & CO2 pollution to save the people for a healthy life.
- iv) Awareness programs will be organized to make people aware and concern of possible natural calamities, disaster preserve forestry and training them the way and means to save from danger.
- v) Voluntarily support during natural calamities.

AGRICULTURE :

- i) To organize training and awareness programs for modernization of agriculture, multiple cropping etc. to raise the level of consciousness, productivity, income and standard of living of the farmers.

6. Membership:-

a). Qualification to become member:-

The membership of the society will be given to any Indian citizen who :-

- (i) He/She has attained the age of eighteen years.
- (ii) Promises to abide by the rules and bye-laws and all the decisions taken by the association in respect of the amendments of the rules and bye-laws.
- (iii) Subscribed in writing to carry out the best of his/her capacity the objects of the association.

b). Subscription, Donation etc.

All the members are liable to subscribe lump-sum amount as membership fees/subscription or donation may also be liable to subscribe towards the society so fixed by general meeting time to time.

c). Collection of Fund:-

The fund of the society will be collected from membership subscription/fees, donation from members/well wishers, grants from any Govt. organization and from its own resources, if any.

d). Control of Fund:-

A bank account will be opened in the name of the society in a Nationalized Bank or Post Office, which shall be operated jointly by President & Secretary of the Society.

7. Procedure of the General Meeting:-

- (i) The General Meeting of the society will sit once in a year.
- (ii) The society will convene meetings as per approval of the executive committee or the president
- (iii) A notice to be issued ahead of one month of the scheduled date of the meeting specifying date, time, venue informing of the members with enclosing the agenda of the meeting is discussed.
- (iv) The meeting will be presided over by the President of the society or in his absence by Vice-President or in his absence by Vice-President of the society.
- (v) The President any postpone or adjourn the meeting for time being as may be thought feel subject to the provision of the rules and regulation.

8. Quorum of the General meeting:-

In Presence of 2/3rd members of the total members, the quorum of the General Meeting will be formed, but no quorum in case of adjourned meeting is need so far.

9. Election procedure of the Executive Committee:-

10. Short description of the Executive Committee:-

Primarily the executive committee is consists of 13 members which includes are :-

President-1, General Secretary-1, Vice-President-2, Assistant General Secretary-7 and Treasurer-1 subject to increase in due course if felt necessary.

11. The term of the executive committee:-

The term of the executive committee will be 3 (Three) years, subject to increase or decrease in due course if felt required.

12. Procedure of re-election of the members of the Executive committee:-

The re-election will be held according to the election procedure.

13. Procedure of the meeting of the Executive committee:-

The executive committee will be held at least once in every two month or so far both functioning of the Society.

14. Quorum of the meeting of the Executive committee:-

In pursuance of 2/3rd members of the total executive members, the quorum of the Executive Committee will be formed, but question of quorum in case of adjourned meeting does not arise.


15. Expulsion of undesirable member:-

If any member goes against the rules and regulations of the society, then the same member will be suspend/expelled from the society.

16. Auditor:-

A qualified Auditor will be appointed by the executive committee, who shall audit the accounts of the society at least once in a year and the Annual Audit report will be submitted to the registrar of societies regularly.

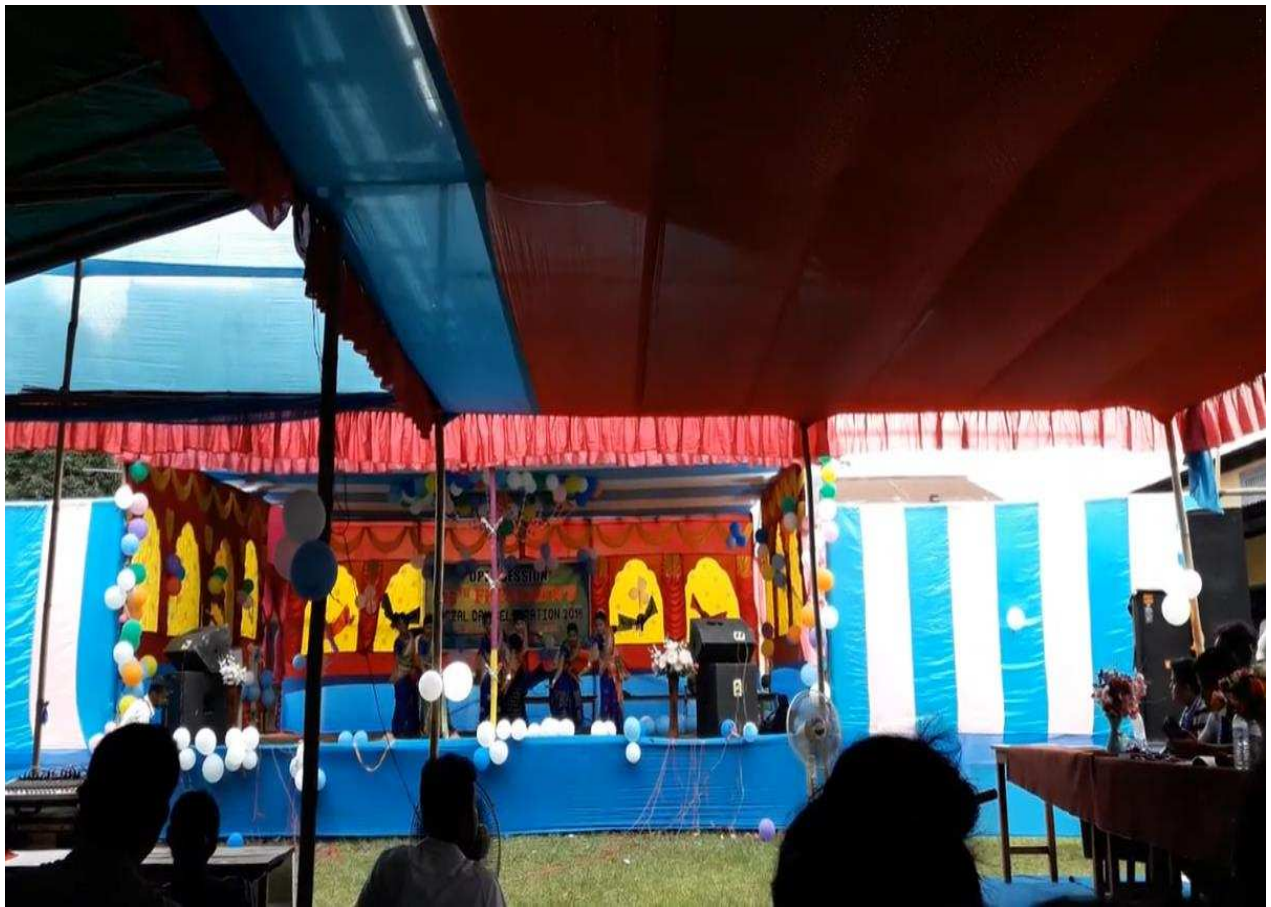
